November 17th, 2018 - All persons authorized to sign on behalf of the LLC must understand how to properly sign on behalf of the LLC or risk incurring personal liability Proper signing requires you to include your name plus wording that indicates you are signing on behalf of the LLC and your relationship to the LLC such as manager or member
